3. Summary of degree programme evaluation meeting for Linguistics (orientation) (11.20-11.35)

The head of department informs the degree programme board about the results of degree programme evaluation meeting for Linguistics and highlights possible degree programme initiatives which have been incorporated into the revised plans of action. The head of department provides the board of studies with the same information at the December meeting.

4. Degree programme board questions for teaching evaluation spring 2024 (decision) (11.35-11.50)

The UN can choose a number of obligatory questions at degree programme level and the order of questions – in addition to the obligatory AU question and possibly the board of studies' obligatory questions. These questions will thereby form part of all the teaching evaluations on the degree programme.

1) "I rate the overall benefit of the course as..." [very significant benefit, significant benefit, some benefit, limited benefit, no benefit]

Previous decision:
