Regarding The Danish Students Survey the question about study intensity of the students were discussed. It is important that the students know about what to take into account when they answer how many hours a week they spent on their studies. - Supplementary subject in cultural data science 2020 language analytics change of exam form since it is not working with two portfolio exams at the same semester.
