#### 3. Visit from the librarian

Libraians Sofie Baungaard Hansen and Johanne Rübner Hansen visited the UN meeting and gave short introductions about the services at AU Library and the Danish Royal Library offer. The concept of Cookies was presented which is a concept where a librarian can come visit either the department at a meeting or students in connection to teaching activities and tell about different subjects (small courses). #### 4. Degree programme evaluation of Linguistics

In the absence of the Head of Department, UN chairperson Ethan Weed presented the process. Head of Department has made a draft of the report and meetings are being held with the individual teachers to get feedback, and there is also a meeting set up with the entire staff group at linguistics.

4.1 Presentation of evaluation focus and input (discussion)

Ethan Weed presented the focus points in the evaluation report:

- Social integration which can lead to dropout
- Both the BA and MA are strong programmes independently. Not all students go from the BA to MA, but that is okay since the MA also attracts students from other BA programs. In general recruiting to the programmes is good.
- It is being discussed what can be done to make it more attractive for students to end up working in health and social services.

The UN has no comments on the focus points, since these will be discussed in more detail in the Linguistics group.
