





### How

- Take one or two courses (but only one in each term – maximum 10 ECTS total)
- Must be included in study programme (i.e you must have room for it in study programme)



### When

Application period: 15/1-21/3 Round 2: 21/3-24/4 Two terms

5 ECTS: two weeks 9-12 + exam 10 ECTS: three weeks 9-13 + exam

Answer after 21/3 and before May 1



### Why

- ✓ Get a head start to your 3<sup>rd</sup> semester
- ✓ To get a different learning experience than during a normal semester
- ✓ To get taught by international guest lecturers
- ✓ These courses are only offered in the summer





## AU SUMMER UNIVERSITY - GOOD TO KNOW



### Message from Head of Studies:

"Summer University is an offer to get flexibility in your study programme, it is not a guarantee to get 10 ECTS, even though you are e.g going on internship on 3<sup>rd</sup> semester"

<u>However</u> More than 95% gets a seat and in 2023 there are about 300 extra spaces for Msc students on 10 ECTS



### north2north - schholarships for students with an interest in the Arctic

Aarhus University is a member of the UArctic network, consisting of universities and other institutions dealing with Arctic themes. The Uarctic is now offering scholarships through the north2north program for student exchange, field courses, etc. in Arctic-related topics. Learn more about the Uarctic network and north2north grants here.

It is also possible for staff and faculty to apply for exchange funding. You can read more here.

### Where can I go?

The participating countries are Canada, Finland, Faroe Islands, Greenland, Iceland, Norway, Russia, Sweden and the United States. You can find a list of participating north2north universities here.

### **Grant sizes**

Grants for study trips range between 1000 - 1500 euros depending on the length of stay (between 2 and 12 months) plus a travel allowance of between 500 1000 EURO.

Scholarships for shorter courses, field courses, and conferences ranges between 1000 - 1500 euros depending on where you are going.



#### Content



Subject to prior approval, a project-based internship can form part of the MSc study programme as part of the electives block.

A project-based internship includes

- A stay in a company
- Participation in the online Career Management Skills course
- A report and from autumn 2020 an oral defence

The purpose of the project-based internship is to give you the opportunity to apply, and reflect on using, the knowledge, skills and competencies you have acquired through your M.Sc. in Economics and Business Administration specialisation in real life practice. You are thus trained in the role of being a reflective practitioner, who, on the one hand, participates in performing relevant practical tasks and, on the other hand, reflects on them from an analytical position.



- > The structure of internships can vary
  - Some are 37 hours a week and others are less
- ➤ The internship must be completed before submission of the report (in the 2022 autumn semester this date is the 4<sup>th</sup> of January **might** change a bit for you guys)

### Number of ECTS points and hours



Internships can be approved with a weighting of 20 ECTS:

	20 ECTS
Project-based internship	444 hours according to 12 weeks of full time work.*

\*) Maximum 40 hours a week.

Only internships equivalent to 444 hours will be approved. You are not obliged to structure the 444 hours as full time work, but you are allowed to structure the hours of your internship over a longer period of time, e.g. if you choose to register for an elective in the same semester. Please note that the internship must be completed before submission of the report (on 4 January).

The final course description for the 20 ECTS project-based internship in the autumn semester of 2021 will be published in the AU course catalogue by mid-April 2021.
